# City of Grand Blanc City Council Minutes of May 11, 2016

Budget Adoption Resolution 05-1603

And General Appropriations Act

WHEREAS: In accordance with the provision of Public Acts 621 of 1978, the Uniform Budgeting and

Accounting Act for Local Government, it is the responsibility of the Grand Blanc City

Council to establish and adopt the annual City Budget; and

WHEREAS: The Finance after due deliberation allocated funds for FY 2017-18 for the Grand Blanc

Fire Commission in the amount of \$103,325; Grand Blanc Parks and Recreation in the

amount of \$120,225 and the McFarlen Library in the amount of \$33,800.

WHEREAS: The Finance Committee received budget requests from all City Departments and has

reviewed in detail the City Manager's FY 2015-16 Amended Budget, 2016-17 Amended

Budget and FY 2017-18 Original Recommended Budget; and

WHEREAS: The Finance Committee, after due deliberation, has formulated a Recommended Budget

total appropriation with available resources for FY 2015-16 at \$8,959,735 FY 2016-17 at

\$10,150,610 and for FY 2017-18 at \$8,201,665; and

WHEREAS: The further intent of this resolution is to designate the Chief Administrative Officer and

Fiscal Officer and to specify the use of Federal Revenue Sharing FY 2015-16, FY 2016-

17 and FY 2017-18; and

WHEREAS: The property tax millage rate proposed to be levied to support general operations will be

11.85 mills and .9 mills for streets.

# **Budget Adoption**

NOW, THEREFORE BE IT RESOLVED, that the Grand Blanc City Council does hereby adopt the FY 2015-16 Amended Budget, FY 2016-17 Amended Budget and FY 2017-18 Original Budget and General Appropriations Act as recommended by the Finance Committee as advertised and placed in the City Clerk's office for public inspection; and

BE IT FURTHER RESOLVED, that the City Manager is hereby designated the Chief Administrative Officer of the City of Grand Blanc and, further, that the City Clerk shall perform the duties of the Fiscal Officer as specified in Public Act 621 of 1978, the Uniform Budgeting and Accounting Act of Local Government; and

BE IT FURTHER RESOLVED, the appropriation accumulated at the summary level of expense for each City Department shall be deemed the maximum authorization to incur expenditures and the Fiscal Officer shall not approve any expenditures beyond that originally approved or amended by the City Council and;

BE IT FURTHER RESOLVED, the Grand Blanc City Fund Balance Policy was adopted on May 11, 2016 and is in compliance for FY 2015-16, FY 2016-17 and FY 2017-18;

BE IT FURTHER RESOLVED, the property tax millage rate proposed to be levied to support general operations will be 11.85 mills and .9 mills for streets.

Motion by Blondell supported by Nielsen to approve the above budget resolution with total appropriations of \$8,959,735 for FY 2015-16, \$10,150,610 for FY 2016-17 and \$8,201,665 for FY 2017-18 and the property tax millage rate of 11.85 mills for general operations and .9 mills for streets.

# b) Resolution 0516-01 – MDOT Contract for Saginaw St Safety Grant City of Grand Blanc Resolution 0516-01

WHEREAS, The City Council for the City of Grand Blanc approves the contract #16-5194 with the State of Michigan Department of Transportation for Part A Grand Blanc High School driveway relocation along Saginaw Street between Perry and Holly Roads; including box span layout traffic signal upgrade, countdown pedestrian signal, and concrete sidewalk and ramp work; and all together with necessary related work.

NOW, THEREFORE BE IT RESOLVED, that the City of Grand Blanc hereby authorizes the City Manager Wendy Jean Buhrer and the Assistant City Manager/City Clerk Bethany J. Smith of the City of Grand Blanc to sign the contract.

Motion by Blondell supported by Creasey to approve Resolution 0516-01. Motion carried.

# c) Resolution – 0516-02 MDOT Contract for Bella Vista Dr

City of Grand Blanc Resolution 0516-02

WHEREAS, The City Council for the City of Grand Blanc approves the contract #16-5193 with the State of Michigan Department of Transportation for road reconstruction work along Bella Vista Drive from Via Catherina Drive northeasterly to Bella Vista Court (north limits of the City of Grand Blanc); including pavement removal, hot mix asphalt surfacing, machine grading, drainage improvement, concrete curb and gutter, sidewalk and ramp work; and all together with necessary related work.

NOW, THEREFORE BE IT RESOLVED, that the City of Grand Blanc hereby authorizes the City Manager Wendy Jean Buhrer and the Assistant City Manager/City Clerk Bethany J. Smith of the City of Grand Blanc to sign the contract.

Motion by Blondell supported by Nielsen to approve Resolution 0516-02. Motion carried

### Finance

Motion by Blondell supported by Creasey to accept the recommendation from Finance and approve Resolution 0516-03 authorizing an inter-fund loan from General Fund to Local Street Fund for FY 2016-17 Local Street projects to include a 1% fee. Motion carried.

Motion by Blondell supported by Nielsen to accept the recommendation from Finance and approve the \$10,000 reimbursement from Tax Fund to General Fund in repayment of startup cash as the beginning of the FY 2015-16. Motion carried.

Motion by Blondell supported by Gillies to accept the recommendation from Finance and approve the \$10,000 payment from General Fund to Tax Fund for startup cash at the beginning of FY 216-17. Motion carried.

Motion by Blondell supported by Nielsen to accept the recommendation from Finance to select Fifth Third Bank as the underwriter for the MERS Pension Bond Issuance. Motion carried.

### Public Works

Motion by Nas supported by Blondell to accept the recommendation from Public Works and contract with Fleis and Vandenbrink for the Bella Vista Drive Reconstruction, choosing option 3 – inspection services will be shared between F&V and the City with F&V providing administration and staking. Motion carried.

Motion by Nas supported by Blondell to accept the recommendation from Public Works and contract with M&M Pavement Marking to restripe the City's roads ad on street parking stalls not to exceed \$7,278. Motion carried.

Motion by Nas supported by Blondell to accept the recommendation from Public Works to replace the Water Plant #7 gate operator not to exceed \$4,640. Motion carried.

## Public Safety

Motion by Blondell supported by Gillies to accept the recommendation from Public Safety to deny the request from Mr. Hoffman to close Grand Blvd for a private event. Roll call vote: Blondell; yes, Gillies; no, Creasey; no, Nas; yes, Douglas; no, Nielsen; no. Motion fails 4-2.

Motion by Gillies supported by Creasey to approve the request from Mr. Hoffman to close Grand Blvd on Saturday June 4 from 11:00AM to 5:00PM for a private event. There are to be no alcoholic beverages served and this will not be a precedent setting approval. Rationale: The special circumstances are that he is the only property owner on the street and for the health and safety of the event attendees. Roll call vote: Gillies; yes, Creasey; yes, Nas; no, Blondell; no, Douglas; yes, Nielsen; yes. Motion carried 4-2.
